The EMRC commenced a compost and mulch trial, funded by Strategic Waste Initiative Scheme, at Sandalford Wines on 5 May 2008.

Recycled organic material, in the form of mulch and soil conditioner produced at the Red Hill Waste Management Facility, was spread along the vines. The soil around the vines will be monitored over the next two years for its structure and

TYRED YET?

The Environmental Protection and Heritage Council (EPHC) have released a consultation package on tyres for public comment.

The package includes:

- ◆ Regulatory Impact Statement (RIS) for end-of-life tyre management;
- ◆ Tyre product stewardship agreement;
- ◆ Draft National

Environmental Protection (Tyres) Measure (NEPM);

- ◆ NEPM—Impact statement;
- ◆ Tyre NEPM Threshold study; and
- ◆ ATIC End-of-life tyres leaflet.

The Municipal Waste Advisory Council will be making a submission on these documents and is seeking the input of local government. Due to the length of the documents MWAC has developed a

summary of each. These summaries, as well as MWAC comments, will be available from the WasteNet Website, www.wastenet.net.au, on Monday 23 June.

Feedback to inform the MWAC submission is due by **COB Friday 4 July**.

AWT ON THE LINE

There is currently a Standing Committee on Environment and Public Affairs on the SMRC's Regional Resource Recovery Centre in Canning Vale.

MWAC will be sending correspondence to the Standing Committee in support of the facility and outlining situation for local government. We will highlight the following points:

- ◆ All of the metropolitan Regional Councils are moving towards

alternative waste treatment (AWT) and these facilities represent a huge potential to reduce waste to landfill and consequent greenhouse gas emissions;

- ◆ The initiative that local government is taking needs support from the State Government;
- ◆ There is only limited planning for future landfill therefore maximum diversion needs to be achieved;
- ◆ AWT facilities need to be located within the Perth

metropolitan area (reducing both fuel consumption and greenhouse gas release).

This Standing Committee offers the opportunity for local government to show its support sustainable waste management.

THE GREAT CARBON DEBATE

The Waste Management Association of Australia (WMAA) has formed a National Carbon Committee (NCC). The formation is partly in response to the increasing debate over whether to include waste in an emissions trading scheme (ETS).

In a recent media statement the NCC called for consideration of the emissions avoided through recycling in shaping the

Australian Emission Trading Scheme (AETS).

The NCC's response to the Garnaut Review's Emission Trading discussion paper, was that the emissions abated through resource recovery and recycling, by avoiding the production of goods from raw materials should be taken in consideration in the AETS.

The Committee Chair commented that it would appear that the Scheme will

only deal with emissions from landfill.

C&D—ALL WRAPPED UP

The Waste & Resource Action Programme (WRAP) in the UK has recently welcomed the launch of the Governments Strategy for Sustainable Construction.



The Strategy has set a target to halve the construction waste to landfill by 2012. WRAP is supporting the strategy by developing voluntary agreements with the construction industry.

These agreements will provide the industry with a standardised framework and measurement tool for delivering the waste reduction targets, that are part of the

Strategy for Sustainable Construction.

WRAP believes that the targets are highly achievable and that there are many organisations that have made a positive progression towards it.

WRAP has indicated that to

significantly reduce the amount of waste going to landfill there will need to be a co-coordinated effort that effectively targets all stakeholders within the supply chain.

WRAP intend to work closely with other organisations in order to successfully achieve this target.

BETTER THAN VIRGIN

Scottish manufacturers Brand and Rae have produced over one million breeze blocks (cement blocks) in the last 18 months using recycled glass.

The crushed glass replaces some of the sand that would normally be used. It assists

builders in reaching the local authority requirements for using a ten per cent recycled material component in construction projects.

The glass helps provide better



weather resistance, a cost saving and a slight reduction in the amount of concrete used, compared to using virginal material.
