200 VOTES FOR HHW

The Waste Authority, Western Australian Local Government Association and Rivers Regional Council held a Household Hazardous Waste (HHW) Pilot Collection Day on Saturday 6 September 2008.

It was hosted by the City of South Perth from 9.00am to 1.00pm at the City of South Perth Civic Centre, Corner of South Terrace and Sandgate Street, South Perth.

Even though the day coincided with the State election, over 200 attendees dropped off household hazardous waste.

The next HHW Pilot Collection Day will be hosted by the Southern Metropolitan Regional Council (SMRC) **9.00am to 1.00pm on Saturday 4 October** at the Regional Resource Recovery Centre, Bannister Road, Canning Vale.

Items that are not covered by the HHW Program include used oil, asbestos, electronic waste, waste from commercial/industrial businesses and containers larger than 20L.

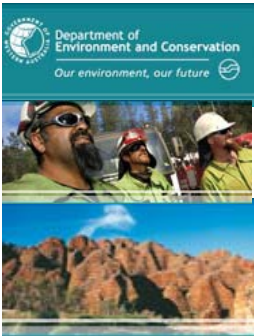

WHO'S YOUR SUPPLIER?

The WA Local Government Association is seeking to put in place a used oil collection Preferred Supplier Agreement which would provide an effective used oil collection and recycling service to Local Government. A Preferred Supplier Contract means an arrangement with WALGA operating for the benefit of its members, which under the Local Government (Functions

and General) Regulations, 1996, enabling Local Governments direct accesses to Contracts, without the need to Tender. The State Government, through the Waste Authority, has granted funding of \$150,000 per annum for 2 years to assist Local Government to recycle used motor oil. Funding will be provided to Local Governments for up to 50% of the cost of

LOVE ME TENDER

The WALGA Tender Bureau Service is a consultancy service designed specifically for WALGA members who need to engage professional procurement specialists.

The Tender Bureau Service are in the process of finalising a Preferred Supplier Contract for Heavy Plant, General Plant and Utility Equipment. This new contract should include companies such as Westrac, CAT, Hitachi, Conplant, Komatsu, CJD Equipment (Volvo), Earthwest (Hyundai)

and Liftrite. Members buying off this Contract will save on average 15% off the marked price for plant and equipment.

WALGA will also be providing a facility for the disposal of used plant and equipment through the Tender Bureau Service.

SUPERMARKETS BAN TOGETHER

IGA Stores in Mosman Park and Cottesloe will be plastic bag free from 3 November 2008. Instead of giving away plastic bags, they will be offering free paper bags and have reduced the price of green and string bags.

Mosman Park IGA Store Manager Stuart Arnold said

that store owners and staff that by not providing plastic bags, they were being environmentally responsible in reducing landfill and preventing plastics bags from ending up in waterways.

Former Environment Minister David Templeman said that the government was

committed to phasing out plastic bags however did not support a ban or tax on them. He said that phasing out of plastic bags was best done at a national level to make a real difference.

DATA WASTE

LEAKY LANDFILL



Recently residents from 400 households have been strongly advised to vacate the Brookland Greens Estate in Melbourne's suburb of Cranbourne due to methane leaking from the nearby landfill.

The Stephenson's Road landfill is managed by the City of Casey and was closed in 2005.

According to *The Age*, Casey Council predicted this potential problem and objected to developers

building so near to the landfill, however had its decision overturned at the Victorian Civil and Administrative Tribunal.

The City of Casey supplied the EPA and Country Fire Authority (CFA) with monitoring results and reports of a local residence that required the occupants to relocate last week, as well as the results for neighbouring properties.

The CFA says there is a very real risk of explosions and wants some residents to

consider relocation. The level of methane in the wall cavity of the residence has now been confirmed at 60%. Further tests found pockets of methane in the ground (under the house) to be approximately 20%. Methane can ignite when it reaches concentrations of 5 to 15%.

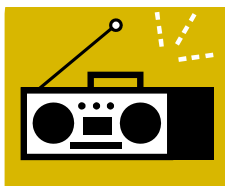

SENATE RESULT

The Standing Committee on Environment, Communication and the Arts recently held an inquiry into the Management of Australia's Waste Streams and the consideration of the Drink Container Recycling Bill 2008.

WALGA made a submission to the Senate Committee Inquiry. The Inquiry received over 90 submissions. The Senate Inquiry released its Report on 3 September and the Committee recommended:

◆The Environment Protection

and Heritage Council consider initiatives, including container deposit schemes, to improve away-from-home recycling. Such initiatives should include elements such as an incentive to recycle, convenience, adequate infrastructure and a supporting education and awareness program.

◆The Commonwealth Government calculates options to send a direct and undiluted price signal to the market and publishes the greenhouse benefits of recycling or landfill gas

reduction, capture and use as part of its deliberations on the Carbon Pollution Reduction Scheme.
